Non-refundable bid document fee is payable in cash between **07:30am** and **15:30pm** at the cashiers in the Rates Hall, Metsimaholo Local Municipality.

Bids **endorsed** with their specific Bid Numbers must be placed in the tender box located at **Metsimaholo Local Municipality, Ground floor, Civic Centre, Fichardt Street, Sasolburg** No faxed or e-mailed bids shall be accepted. The municipality reserves the right to accept any tender price and not necessarily the lowest, and to withdraw any bid before the award.
